- Approximately 19,000 were at the gathering site on Sunday. Again, based on vehicle
 counts, these total numbers may be low due to people arriving using different modes of
 transportation such as bicycles, on foot, or in shuttles.
- There was a significant amount of nudity noted in Kiddie Village on July 4.
- In addition to dogs left on site, abandoned vehicles have been identified as an issue. The Forest Service will be using the abandoned property avenue to deal with them. The California Highway Patrol stated that they could assist on a case-by-case basis if the vehicle were on a road or a visual hazard.
- The Special Use Administration (SUA) Team is down to one person on site with a continuing focus on compliance with the permit and needed rehab. Lynn Bidlack is working on a notice of noncompliance using the latest statistics. Most people will be leaving the site over the next several days although a number will be remaining on site to do rehabilitation (rehab) over the next several weeks.
- Some significant impact in an aspen grove occurred that will take 5-10 years to recover. The Forest Service will be meeting with the Rainbow participants about rehab in the grove and in the entire gathering area.
- Temporary Forest Orders are being amended to accommodate rehab efforts and to reduce camping sites to one area.
- The Ranger will be going out on the site used by the Gathering with several range permittees Friday, July 9. Cows and sheep will be going on the allotments shortly.

 counts, these total numbers are low due to people arriving using different modes of
 transportation such as bicycles, on foot, or in shuttles.
- The main celebration was yesterday, when numerous participants gathered to pray for world peace and mother Earth. The day passed without major incident.
- The Special Use Administration (SUA) Team is down to two on site with a continuing focus on compliance with the permit.
- A Forest Service soil scientist began measuring soil compaction as preliminary rehab efforts are set to begin. Studies indicate that compaction in the heavily traveled kitchen and trail areas was fairly minimal with little disturbance at lower levels of soil. The rehab proposed for these areas will focus on raking the top 1" of soil to break it up and then by spreading nearby woody forest debris known as "litter" or "duff" to protect the soil. All dug out areas will be filled in. Some trail areas will need water "bars" to divert water off the trail at various intervals. Participants of the gathering have indicated that the Rainbows will purchase any native seed needed to re-vegetate the site. Rainbow volunteers, supervised by Forest Service resource specialists, will accomplish the bulk of the rehab. Other rehab activities are being designed as well.
- Members of the Fort Bidwell Indian Community Council and the Pit River Tribe have requested to go out on site with the Forest Supervisor later this week. David Ferrell, WO Assistant Director of Law Enforcement, is meeting with Tribal Chair Francis Bennally in Reno today, regarding tribal concerns.

Current Situation:

- The conservative estimate of the number of people at the Gathering was 15,992 as of noon on July 3, in contrast to the 13,200 estimated at noon on the 2nd. Based on vehicle counts, these total numbers are low due to people arriving using different modes of transportation such as bicycles, on foot, or in shuttles, which make numerous trips a day. License plates reflect visitors from 40 states; and 8 countries. Parking areas are filled and overflow areas are being used. There was some confusion on the 3rd with parking areas by Gathering parking moniters which resulted in cars being parked outside of permitted areas.
- The Special Use Administration (SUA) Team continues to work on some noncompliance issues with kitchens, campsites, and garbage removal. New campers, many arriving at night, are continuing to camp within 150' of water. The accumulating amounts of garbage are now being bagged and are being slowly disposed of.
- As a result of Tribal concerns, sensitive areas have been designated and all use in those areas has been moved by Gathering participants. As background, members of the Fort Bidwell Indian Community Council, Cedarville, Alturas, and Susanville Rancherias and Pit River Tribe met with the Rainbow Council yesterday to discuss their concerns with the Gathering. Stan Sylva, Forest Supervisor, Tim Lynn, IC, Dan Meza, Forest Tribal Relations Program Manager, and Gerry Gates, Forest Archaeologist and law enforcement escorts affended for the Forest Service. Members of the tribes delivered passionate messages about the need for respect for people and the land, the need for advance notice, expectations of reasonable dialogue, and that Rainbow Leadership needed to observe regulations and lead by example. Tribal members were appreciative of the support received from the Forest and also expressed their support of law enforcement efforts both at the meeting and on the site.

Stan Sylva, Forest Supervisor, Tim Lynn, IC, Dan Meza, Forest Tribal Relations Program Manager, and Gerry Gates, Forest Archaeologist are attending for the Forest Service.
- As a result of tribal concerns, sensitive areas were designated and a Forest amendment to the Special Use Permit was put in place. The amendment states that: in designated sensitive areas, no new digging is allowed and campfires can only be placed on the surface of the ground. No digging of new fire pits is allowed. Sensitive areas are being flagged today.

- Due to a recent incident, the Safety Officer said that all employees working in the gathering need to contact law enforcement when they receive threats.
- There was a concern that we need an information sign within the gathering with FS regulations. The main sign is now located at the entrance of "Welcome Home" where the Alcohol "A" camp is located. We were told that not many of the gathering participants will go there because of the type of behavior in "A" camp. Information will be posted at the Gathering's Information Center with FS regulations that apply to the area.
- A fire prevention technician is on site daily from 10-2 issuing campfire permits. The system is working well.
- Senator Doolittle was contacted by a Modoc County Supervisor regarding a concern of a
 permittee about "water rights." In fact, the grazing permittee does not have "water
 rights" on the site.
- The County Supervisor is also concerned about the cost to the county. Doolittle's staffer mentioned petitioning Congress to repay the county.
- Paiute representatives were on the site yesterday and expressed concern because this is a traditional plant gathering area. They had major concern about the digging of slit trenches and compost pits and disturbance of archaeological artifacts. They said it was

Temporary Land Use Restriction Orders

A large group of up to 20,000 individuals is expected to be on the Warner Mountain Ranger District by July 1. At this point no noncommercial large group use permit has been issued. However, U.S. Forest Service officials are working on the compliance with the permit requirements.

At the present time to protect natural resources and public uses for the large number of visitors associated with the Rainbow Family Gathering, the Modoc National Forest has approved Temporary Land Use Restrictions within the impacted area of the South Warner Mountains. The area runs from the Forest boundary at the entrance of West Valley northeast to Mill Creek Falls then follows the South Warner Wilderness boundary.

The following restrictions apply to all forest users of the impacted area and are effective from June 17 through August 1, 2004.

- 1. Camping within 150 feet of any running stream or body of water.
 - To protect streams, other bodies of water and riparian areas.
- 2. Being publicly nude.
 - Nudity is offensive to some members of the public who could be traveling through the regulated area.
- 3. Possessing a dog not on a leash or otherwise confined.
 - To provide for the health and safety of visitors.
- 4. Placing kitchen facilities (including food preparation areas), gray water pits, or slit trenches within 300 feet of any running stream or body of water.
 - Where large quantities of food are prepared over multiple days, 300 feet is necessary to prevent pollution from entering water. This distance is also required for slit trenches to manage human waste away from water sources.
- 5. Parking or leaving a vehicle in violation of posted instructions.
 - Parked or abandoned vehicles can create a variety of hazards.
