I can understand notifying participants that they are performing under an approved permit. In fact a nice bold large sign would be likely appropriate to give everyone attending fair notice. But I am not sure that we will have much support in the court (should we need to cite) if folks aren't given the fair and legal notice that there is a signed permit and for that matter for a legitimate process they should be entitled to the complete record and be able to have some sort of opportunity to discuss this with the "rainbow organization". Secret permits are not how the government should work. Note that the CFR mentions the signer and that their safety in signing is a concern but not so much that it should significantly impact the permit screening application process. LE is available for any threats to our visiting public and permittees. Pardon any errors -- message remotely composed.
